HOTO is a USRowing registered regatta sponsored by the Occoquan Boat Club and organized with the assistance of the following Occoquan River rowing organizations: Woodbridge High School, Robinson High School and Thomas Jefferson High School. The FINAL RESULTS reflect eight (8) finish order changes resulting from a review of the original starting line and finish line log sheets.
